Storm charge adjustment

You will see a slight increase in the storm charge portion of your bill as part of a routine adjustment effective this month. This charge, which helps pay for previous hurricane restoration costs and builds the reserve for future storms, is adjusted periodically during the year following Florida Public Service Commission review and approval. The storm charge, effective June 2, will be \$1.85 per 1,500 kWh for small, non-demand business customers. View information about your specific rate class: >>> FPL.com/rates

Save with new lighting choices

Federal lighting standards become effective in July, requiring manufacturers to produce more efficient fluorescent lights for use in offices, schools and other commercial facilities. You can save up to 25 percent on your lighting expenses each year by using some of these more efficient options. One option is to retrofit older T12 fluorescent light fixtures with high-performance T8 lamps with electronic ballasts. Learn more about lighting:
